- 5) Review of relevant questions to be presented to Hilton Yee, the Senior Project Manager for URS/AECOM. This company was selected by the City of Los Angeles to provide pre-design, design and design support services for the restoration project that will stabilize the ground and reconstruct the Paseo Del Mar roadway. Written questions will be accepted in advance and at the community briefing to be held on Wed., October 28<sup>th</sup> at 6:30 p.m. at the Cabrillo Marina Community Room. This is an opportunity for the public to make suggestions and ask questions in advance of any design effort. Our input could help determine the direction of the project.

6) Discussion and possible Motion Item:

The residents of Paseo Del Mar and the lower Palisades area continue to express their concerns on the present and the long term traffic issues on Paseo Del Mar resulting from the rebuilding of Paseo Del Mar, over the White Point Landslide. It is expected that this will greatly increase the volume of traffic, related noise issues and traffic violations in the lower Palisades area. It will be requested that a detailed traffic plan be developed and implemented along with the above mentioned plan to rebuild Paseo Del Mar at the White Point Landslide area.
