The residents of Paseo Del Mar and the lower Palisades area continue to express their concerns on the present and the long term traffic issues on Paseo Del Mar resulting from the rebuilding of Paseo Del Mar in the area of the White Point Landslide. It is expected that this will greatly increase the volume of traffic, related noise issues and traffic violations in the lower Palisades area. It was suggested that a detailed traffic plan be developed and implemented along with the above mentioned plan to rebuild Paseo Del Mar at the White Point Landslide area.
