*The Coastal San Pedro Neighborhood Council recommends denial of the project proposed for 2111 Pacific Ave. as currently proposed but will offer support if the project provides one parking space for each bedroom, if the project is limited to three stories not exceeding 30 feet, and if the affordable housing for the project is increased to 24 units.*
