8. Winter Shelters- Discussion of where San Pedro residents are directed and early opening of the Winter Shelter in poor weather.
9. Discussion of Ron Galperin's Audit of HHH spending and possible motion to support findings (excerpt from letter to Mayor Garcetti):

“In order to reduce Proposition HHH project costs and development timelines, prevent any potential future delays, and strengthen the bond program’s financials, the City should:

- Put a greater focus on innovative practices to save time and money, including ways to reduce costs on approved or conditionally-approved projects, and consider using any savings achieved for temporary shelters, bridge housing, hygiene centers and other service

facilities to address more immediate needs.

- Streamline the permitting process and add needed personnel to ensure quicker development approvals and processing.

- Centralize accounting responsibility in one City department.

The recommendations in this review are intended to help the City's Measure HHH program achieve its voter-mandated goals, while also ensuring that valuable taxpayer dollars are managed transparently and carefully.”
