Homelessness Committee

Whereas, the Coastal San Pedro Neighborhood Council recognizes Mayor Garcetti's declaration and proposal for "Crisis and Bridge Housing Fund" to accelerate the construction of emergency shelters in Los Angeles;

Therefore, be it resolved, the Coastal San Pedro Neighborhood Council requests that Council District 15 (CD15) publically commit to timely site selection; and

Be it further resolved, the Coastal San Pedro Neighborhood Council requests that CD15 staff work with all seven (7) Neighborhood Councils of the Harbor Alliance of Neighborhood Councils and the Watts Neighborhood Council to select potential sites for this program before the funds become available in July; and

Be it further resolved, the Coastal San Pedro Neighborhood Council is committed to working with the other Neighborhood Councils of CD15 to identify and select the appropriate location for the "A Bridge Home" site.

13. Motion to endorse Proposition 68 (the California Clean Water and Safe Parks Act) on the June 5, 2018 ballot.

Whereas, California faces frequent and intense droughts, devastating wildfires, and growing challenges from climate change that threaten our water, parks, coastline, access to the outdoors, and natural resources; and

Whereas, Our water, parks, and outdoors are what makes California special, and we must safeguard our open spaces, access to our coast, natural areas, forests, and beautiful places where families hike, camp, swim and play; and

Whereas, Families in some underserved communities in California have water that is so contaminated that they cannot turn on the tap and get clean water to drink; and

Whereas, Many communities lack access to safe neighborhood parks for children to play and exercise; and Whereas, A clean, reliable water supply is essential to the health of our families and strength of our economy, and supports an \$87 billion outdoor recreation and tourism industry that provides over 700,000 jobs; and

Whereas, It has been 15 years since California passed a bond to provide funding for natural resources; and

Whereas, Proposition 68 is a general obligation bond that invests \$4.1 billion in the coming years for some of California's most pressing water, parks, and natural resource needs; and

Whereas, Proposition 68 provides \$1.7 billion to ensure clean drinking water, prepare for the next drought, clean up groundwater, capture and recycle more water, and keep toxic pollutants out of California's rivers, lakes and streams that supply clean water; and

Whereas, Proposition 68 dedicates \$1.3 billion to create safe parks for every child, improve parks in neighborhoods with the greatest need, repair local and state park facilities, and restore and expand access to outdoor recreation throughout California; and

Whereas, Proposition 68 invests \$1.1 billion to protect California's natural resources to prevent wildfires, restore rivers, lakes, streams and natural areas, prevent toxic air pollution, address climate change, and protect our coastline to increase access to our coast and beaches; and

Whereas, All regions of the state will benefit from these investments with strict accountability to ensure funds will be spent efficiently and for intended purposes;

Therefore be it resolved, that the Coastal San Pedro Neighborhood Council supports and endorses Proposition 68 on the June 5, 2018 statewide ballot, and hereby adopts this resolution the 21st day of May, 2018.

Whereas the California Coastal Commission mandates maximum public access to public beaches, and Whereas the City of Los Angeles implemented the curfew in 1989 without the state required Coastal Development Permit, and

Whereas the main issues expressed by stakeholders regard late night beach disturbances that are illegal whether or not a beach curfew exists, and

Whereas such issues can be addressed by increased enforcement;

Therefore be it resolved that the Coastal San Pedro Neighborhood Council supports rescinding the beach curfew.

17. Motion recommending that the Dept of Recreation and Parks work with the Trust for Public Land to secure funding for repairs and upgrades to the Sunken City.



MAYOR GARCETTI'S CRISIS AND BRIDGE HOUSING FUND

What Angelenos Can Expect to See Next: A Bridge Home

Measure H is generating \$355 million each year on the LA County level to provide a wide range of services to help people in desperate need; Proposition HHH is giving LA City \$1.2 billion to build 10,000 units of supportive housing over the next decade — units that will be paired with those same services, so that unsheltered Angelenos can go home for good.

But while we ramp up the work of building those units, we must be equally impatient about finding safe places to sleep for people who are on the streets tonight. That's why Mayor Garcetti has launched a new plan called A Bridge Home — to get unsheltered Angelenos under a roof as quickly as possible. Emergency Shelters: More options, Creative Solutions, Expedited timeline.

Declaration of Shelter Emergency

Los Angeles is the first city in California to take advantage of a new state law that, when issued along with a Declaration of Shelter Emergency, enables cities to construct homeless shelters on any land owned or leased by the city. The new law also exempts cities from complying with certain state and local regulations, to the extent that these laws hinder or delay cities' ability to mitigate the homelessness crisis.

Crisis and Bridge Housing Fund

To accelerate the construction of these shelters, the Mayor's FY '18-'19 budget will include a \$20 million to construct emergency shelters city-wide. Because there is a need for additional shelter beds across the city, these funds will be equally available to each council district (\$1.3M per council district). To receive the funds, each Council Member must identify a site or building adjacent to a high-density homeless population, and create an emergency shelter.

Homeless Ends One Interaction at a Time

In the months leading up to these new shelters opening, the County will direct unprecedented outreach, mental health, career, and addiction support services to encampments to help prepare homeless Angelenos to move indoors.

Keeping Our Neighborhoods Clean

Once Council Districts stand up their shelters and homeless Angelenos move into them, the City's Sanitation department will work to restore spaces that were previously encampment sites into safe, clean, public passageways.

On a Path to Permanent Home

These emergency shelters will remain standing for three years — enough time for the City to construct supportive housing for the Angelenos living in them. The supportive housing will be furnished with onsite mental health, employment, addiction, housing placement services, and wellness resources.

HOMELESSNESS IN LOS ANGELES COMMON TERMS

A Bridge Home – At the 2018 State of the City address, Mayor Garcetti announced that the Mayor's FY '18-'19 budget will include a \$20 million to construct emergency shelters city-wide. Because there is a need for additional shelter beds across the city, these funds will be equally available to each council district (\$1.3M per council district). To receive the funds, each Council Member must identify a site or building adjacent to a high-density homeless population, and create an emergency shelter by July 2018.

Coordinated Entry System (CES) – CES coordinates supportive services and housing resources across Los Angeles County, to form a collaborative, no-wrong door network that connects homeless individuals and households to services and housing.

Homeless Management Information System (HMIS) – The Los Angeles Continuum of Care (LACoC) HMIS is a local information technology system used to collect client-level data and data on the provision of housing and services to homeless individuals and families and persons at risk of homelessness.

Measure H – Measure H is a LA County ballot measure that passed in 2017. It will provide \$355M annually to fund homeless services throughout the county.

Measure HHH – Measure HHH is a LA City ballot measure that passed in 2016. It will provide \$1.2B over 10 years to create 10,000 additional units of permanent supportive housing (PSH).

Los Angeles Homeless Services Authority (LAHSA) – LAHSA's primary role is to coamordinate the effective and efficient utilization of federal and local funding in providing services to homeless people throughout Los Angeles City and County.

Permanent Supportive Housing (PSH) – PSH units are for individuals and families who are homeless or chronically homeless. PSH is housing combined with services, which may include mental health and health services, drug and alcohol treatment, and education and job training.

Unified Homelessness Response Center (UHRC) – The City of LA is establishing a UHRC as the centralized location for coordination of services. The center will be located within LA's Emergency Operations Center in downtown LA.

Dear Applicant:

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably expect to be a publicly supported organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Accordingly, during an advance ruling period you will be treated as a publicly supported organization, and not as a private foundation. This advance ruling period begins and ends on the dates shown above.

Within 90 days after the end of your advance ruling period, you must send us the information needed to determine whether you have met the requirements of the applicable support test during the advance ruling period. If you establish that you have been a publicly supported organization, we will classify you as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. If you do not meet the public support requirements during the advance ruling period, we will classify you as a private foundation for future periods. Also, if we classify you as a private foundation, we will treat you as a private foundation from your beginning date for purposes of section 507(d) and 4940.

Grantors and contributors may rely on our determination that you are not a private foundation until 90 days after the end of your advance ruling period. If you send us the required information within the 90 days, grantors and contributors may continue to rely on the advance determination until we make a final determination of your foundation status.

Why would you want to serve with Neighborhood Council Budget Advocates (NCBAs)?

Budget Advocates are charged under the City Charter to report on all concerns as relate to financial matters of the City of Los Angeles. With 4 million residents and 3 dozen Departments employing over 59,000 workers, the City's annual budget totals nearly \$10 billion operating within a complex financial system.

Even with an enormous budget, when we ask about services such as tree trimming, failing streets, long waits to speak with the police operator, etc. we hear it's "not in the Budget." Every service we expect from the City is delivered based on the Budget.

This is where Budget Advocates come in and serve an important role. Budget Advocates:

- Affect the priorities in the Budget and encourage needed transparency and accountability.
- Make recommendations to address the concerns of our neighborhoods.

Responsibilities of a Budget Advocate include a commitment to:

- Convene twice a month currently the 1st Monday and the 3rd Saturday. Study how the City functions, the challenges it faces, and how the Budget works. Participate in NCBA events.
- Meet with top managers in City Departments during business hours. See how departments operate and what they need to respond to requests for services.
- Prepare White Papers, reports and letters outlining issues across City government as well as performance within specific City Departments.
- Share Budget Advocate reports and recommendations with the Mayor and his Budget Committee
 while asking the Mayor probing questions. Attend hearings and present NCBA recommendations to
 the Budget & Finance Committee of the City Council.
- Convey the work of the NCBAs to Neighborhood Councils & bring their concerns to the City.
- Fill support roles outreach, media, website, writing, editing, surveys, etc.

How to become a Budget Advocate:

- 1) Be designated a Budget Rep. by your Neighborhood Council. You need not be a Board member.
- 2) Attend Budget Day at City Hall Saturday, June 23rd 2018.
- 3) Bring your interest in how the City works its budget, then run for an open Budget Advocate position in your Region. Budget Representatives elect three Budget Advocates from each of the 12 Regions. Budget Advocates serve two-year terms. A number of vacancies will be filled on Budget Day, will you fill one?
- 4) Elected a Budget Advocate or not, come to Budget Advocate meetings, sign up for committees and/or support roles. Budget Advocates welcome your involvement and you will be in the right place for an opening when it develops.
