NPG SCHEDULE AND PROCEDURES - Revised

 DISCUSSION AND CONSIDERATION OF A MOTION TO ADOPT PROCEEDURES FOR DETERMINING NEIGHBORHOOD PURPOSE GRANT (NPG) RECOMMENDATIONS – grant applications will include a copy of the following deadline information, and procedures and processes, to have the process be completely transparent

a. Neighborhood Purpose Grant Application Submission Schedule for Fiscal Year 2017-2018

 First deadline: NPG applications must be received no later than Wednesday, September 6, 2017 by 12:00 pm (noon). REVISED to Friday, October 13, 2017 by 12:00 pm (noon).

ii. Committee to review applications the first or second week in September

- iii. Presentation of committee recommendations to the board at the October 2017 board meeting
- Second deadline: NPG applications must be received no later than Wednesday, January 10, 2018 by 12:00 pm (noon)

v. Committee to review applications the second and third week in January

- vi. Presentation of committee recommendations to board at the February 2018 board meeting
- b. Neighborhood Purpose Grant Application Submission Procedures and Processes for Fiscal Year 2017-2018
 - During committee review, all applicants will be invited to appear before the Budget and Finance Committee at a regularly scheduled meeting, to allow the committee to ask questions.
 - Coastal San Pedro Neighborhood Council (CSPNC) will advertise the availability of Neighborhood Purpose Grants (NPGs) throughout the Coastal San Pedro Neighborhood Council area.
 - iii. All applicants should have a strong involvement in the Coastal San Pedro Neighborhood Council area.
 - iv. Neighborhood Purpose Grant (NPG) applications must be approved by majority vote of the Budget and Finance Committee prior to presentation to the Board.

- d. The application from Harbor L.I.T.E.S. was disqualified for issues with the application related to the 501c3.

- f. Discuss and consider adding more funds to the grant program. <u>It was recommended by the Treasurer to continue at \$2,500 until other budgetary issues have been addressed.</u>
