1. WELCOME AND CALL TO ORDER: Meeting was called to order at 6:30 p.m. by Chair Robert Bryant. There was a quorum with 4 committee members, no board member, and 5 Stakeholders present.

#### 3. TREASURER'S REPORT – Louis Dominguez
