- 1. Technical checkout for online meeting -Technical check completed.
- 2. Voluntary opportunity to say the Pledge of Allegiance. The Pledge of Allegiance was led by Greg Ellis

- 3. Public comment on non-agenda items.
  - a. James Campeau- would like Officer Melanie Shortle to give an update on Whiskey Flats.
  - b. Mayor Garcetti's Office Harbor Representative/Jocelyn Dominguez- Mentor, Train. Hire, and Elevate is a program put on by the Department of Economic Opportunity for the County of Los Angeles. They are looking for employers that would like to partner and help create careerpathways. The wages will be covered by Elevate up to 360 hours. On Thursday night from 5:00PM-6:00PM, there will be a workshop to educate street vendors. They will get all of the information they need to sell legally on the streets. This will be held at the Chamber of Commerce in San Pedro (390 West Seventh Street), in partnership with The Business Force Center,
  - c. The Port/Celia Gonzales she spoke about the homeless encampment at Whiskey Flats and that she had called for a clean-up. As long as the motorhome is parked there they will not clean it up.
  - d. Department of Neighborhood Empowerment/Daniel Johnson You can check for updated trainings at the Empowerla.org website. Mr. Braxton has done his Code of Conduct and Ms.Oruche has done her Ethics which is not updated on the website. There will be a Workplace Violence Workshop on Wednesday, September 28, 2022 as part of the NC Core Institute. BONC met today but he does not have any updates. There is a new NC Marketing Profile that the Communications Department will be using to run ads for the Neighborhood Councils. Lorenzo from the Department is putting CIS leads together for the Neighborhood Councils which they will email out. There will be another Implicit Bias Training coming in regards to Gender Expression and Gender Identity. It is in response to The City's Council File 20-0990 and the Mayor's Executive Order 27. The Congress of Neighborhoods will be this Saturday, there will be a Digital Media Training at the event. Mr. Epperhart mentioned that the Council File System has not been fixed. The NCs have been waiting too long for the new Zoom Accounts. Mr. Pentcheff mentioned there had been no follow up to the Grievance Panel decision he was involved with.
- 4. Call to order and roll call.-The Meeting was called to order at 6:32PM. The attendance at roll call is reflected in the chart above. 14 Board Members were present.
- 5. Board member comment on non-agenda items.
  - a. Ms. Ackerblom- Budget Advocates have scheduled have scheduled the next Budget Day which will be Saturday, June 17, 2022. The Budget Advocates are getting organized and are starting to form the Department Team Meeting Committees. They are looking for volunteers if you are interested. At the next Saturday meeting on the 15<sup>th</sup>. Jacob Wexler from the City Administrative Office will be sharing his knowledge of the City Budget.
  - b. Mr. Gelfand spoke about the Congress of Neighborhoods and invited everyone. He also mentioned the survey that was done by Neighborhood Councilmembers which shows that the Department is spending more time telling us what to do than actually helping us. We will continue to have conversations about what we would like the Neighborhood Council System to look like.
- 6. Approval of prior meeting minutes. The July minutes were approved as presented the August Minutes were postponed.
- 7. Report from Los Angeles Police Department

- a. LAPD/Melody Shortle- in regards to the Whiskey Flats issue, some of the residents are being evicted which could account for some of the additional trash. The Legends Car Show did not have many issues except for a few parking citations. On Friday, October 7, 2022 there will be a Coffee with a Cop from 11:00AM to 1:00PM. Officer Shortle went over the Crime Stats. There are a lot of Kias being stolen right now due to a TikTok hack. Officer Shortle was asked about the body that was found at Twenty Second Street and Cabrillo Marina. She did not have information.
- b. Port Police Morales-had information that the body found was due to an overdose. She had been walking and screaming before she collapsed. She was pronounced dead on the way to the hospital. Officer Morales went over the crimes near the Port. There is a Happy Harbor Halloween event coming up where you can dress up your kids and pets. There will be prizes.
