1) Discussion and possible motion regarding the open LADOT work order to implement NO PARKING restrictions from 10:00 p.m. to 6:00 a.m. along the north side of W. Paseo del Mar along Point Fermin Park.

PROPOSED MOTION

Whereas the parallel parking along the north side of W. Paseo del Mar across from Point Fermin Park is utilized nearly 100% at night by the residents and guests of two apartment buildings and five single family dwellings, and

Whereas, this parking is VITAL and NECESSARY to maintain the stability of the community, and

Whereas there is virtually no street parking available as an alternative on Sheppard Street one block away, and

Whereas, NO PARKING signs along the South side of W. Paseo del Mar are fine as the park is closed during those hours, and

Whereas the Los Angeles Department of Transportation has an open work order to install NO PARKING signs along the both the South and North sides of W. Paseo del Mar and started to do so on the North side at around 11:20 a.m. on December 1st, 2020 but switched sides after Noel Gould explained the situation to the LADOT employee,

Therefore be it resolved, that the Coastal San Pedro Neighborhood Council insists that the Los Angeles Department of Transportation amend the existing work order to exclude the North side of W. Paseo del Mar along Point Fermin Park from NO PARKING restrictions, and

Further Resolved, that in the future, the Coastal San Pedro Neighborhood Council be notified ahead of time regarding plans which make these kinds of significant changes in our community.
