- 1) Call to Order 7:00 p.m.
- 2) Roll Call
- 3) Motion from the chair to define Coastline and Parks in our committee name. Whereas there has been general confusion as to what Coastline refers to in our committee name, and Whereas a clear understanding of our jurisdiction will be of maximum benefit to our Stakeholders, therefore be it resolved that Coastline will henceforth be defined as the Permit and Appeal Area AKA Dual Zone (Dual Permit Jurisdiction Coastal Zone) which runs from Cabrillo Beach to Stargazer Ave and from Paseo Del Mar to the beach below, as shown on the Appendix D map of the San Pedro Specific Plan, and our committee will have primary jurisdiction over all development and zoning applications in the Dual Zone. Be it further resolved that our Parks jurisdiction covers the Recreational Areas shown on the Appendix C map labeled "Special Features" of the San Pedro Specific Plan. Maps are included in the agenda.
- 4) Stakeholder Motion #1: Whereas the Federal facility in front of historical Pt. Fermin Light house is inaccessible for any city department to remove the longstanding graffiti on buildings on site at this facility, and Whereas the expletives defacing them and other graffiti on these unused buildings is a blight to our most beautiful city park and should be removed immediately, Therefore be it resolved that the Coastal San Pedro Neighborhood Council urge Councilman Joe Buscaino of Council District 15 to support and direct the immediate access by Rec & Parks and the city Anti-Graffiti department to maintain this area and the entire park on a daily basis to deter gangs from their daily dirty work.
- 5) Stakeholder Motion #2: Whereas the Los Angeles Marine Exchange on Federal Land needs to be more attentive and responsible for the notification to the Los Angeles Police Department in reporting continued activity not in the best interests of the general public surrounding their facility, mainly in the very parking lot adjacent to their facility, and Whereas the use of drugs, alcohol, sex, litter, and noise has been a long standing issue that goes unreported, even in daylight, Therefore be it resolved that the Coastal San

Pedro Neighborhood Council urge Councilman Joe Buscaino of Council District 15 support and direct this immediate notification to the Marine Exchange and that the Councilman request the LAPD to patrol the guest parking area at the Marine Exchange on a daily and nightly basis. (And/or gate the area).

- 6) Stakeholder Motion #3: Whereas plastics are all around us and part of our everyday life, but single use plastics which are used only for a few minutes and then discarded, have created a major pollution problem and our oceans are filling up with plastic trash, and Whereas we live in a windy coastal community creating a limited time frame for clean up before the plastic blows directly in to the ocean, therefore be it resolved that the Coastal San Pedro Neighborhood Council moves to request any Coastal San Pedro Neighborhood Council sponsored or funded events located in any of the parks within the Coastal San Pedro boundaries, including Angels Gate Park, not provide or serve beverages in single use plastic water bottles.
- 7) Discussion of Recreation and Parks use of Monsanto's Roundup, which contains the cancer causing chemical glyphosate, to groom the areas around trees and fence lines and request a motion from our Committee members demanding that Rec and Parks cease it's use immediately and find other non-chemical means to groom our parks.
- 8) Discussion of the gassing and poisoning of ground squirrels and the damage caused up the food chain, which occurs as a result. Request for a motion.
- 9) Discussion regarding the possibility of opening Sunken City to the public.
