- 3. Public comment on non-agenda items.
 - a. Jocelyn Dominguez Harbor Representative to Mayor Garcetti's office-The Contract Ready LA Event will be held at the Proud Bird. Near LAX on August 27, 2022 10:00AM-12:00PM. It is to help businesses get city contracts and is hosted by the Mayor's Office of Economic Development. She will send a link to the event. There is an update on the Oil and Gas Drilling Ordinance that has been prepared in response to City Council File # 17-0447 which amends the Municipal Code. It prohibits all new oil and gas and makes existing extractions a non-conforming use. Metro Back to School Go Pass Program can provide students with Metro Go Passes free of charge so they can use the public transit system. There is also a Metro Life Program for low-income fare. - 5. Board member comment on non-agenda items.
 - a. Ms. Leach spoke about the charging of parking fees at Cabrillo Beach. They only take Credit Cards not cash and you have to know how long you will stay and pay in advance. Many people were upset so Ms. Leach conducted a survey. She went over the survey results and included problems that the new parking issues are causing for the neighbors in the vicinity. The survey will be sent out to other local Neighborhood Councils.
 - b. Celia Gonzalez spoke on the Cabrillo Beach parking issues.
 - c. Noel Gould- has been receiving emails on the item. There will be an onsite meeting.
 - d. Richard Havenick received an email from Pacific Environment, they are a world-wide environmental organization that works on air quality and reducing the causes of climate change. They are hosting with Long Beach Alliance for Children a Community Town Hall for children with Asthma. It will be on August 31, 2022, 7:00PM to 8:30PM at the Hyatt Regency in Long Beach. 7. Report from Los Angeles Police Department -The Crime Stats were reviewed

- a. LAPD SLO Melody Shortle- gave updates on the events and she discussed the Bloody Thursday Event which will not be returning to Pt. Fermin. The Crime Stats were reviewed. There is a Tik Tok video showing how to steal Kia cars. Theft of Kia's are up. She asked if anyone is interested in being part of Harbor Lights which is an organization that supports the Harbor Division. - 11. Motion regarding transfer of property on Crescent Ave from Los Angeles Department of Water and Power (LADWP) To Port of L.A. Planning, Land Use, and Transportation Committee

2010 with great fanfare, is defined by the Port as "bounded by 22nd Street, Crescent Avenue, and Miner Street." included, at great expense, extensive landscaping and geotechnical work in the Park area between

Crescent Avenue and the Port surveyed boundary near the Crescent Bike Path, and

Whereas, this portion of the 22nd Street Park was properly maintained by the POLA for some years thereafter, and since that time the landscaping maintenance of this area ceased to be done in a regular manner and the Park area along Crescent Avenue has for some number of years become an eyesore for the community and for the POLA, and

Whereas, the Coastal San Pedro Neighborhood Council (CSPNC) has previously brought this to the attention of the POLA in a letter dated September 17, 2019 with the request that the POLA "clear unwanted and invasive vegetation from this area and maintain the clearance with regularly scheduled maintenance" however, the area currently receives no, or only occasional, limited landscaping maintenance for periods of many months at a time, and this has resulted in continuing ongoing deterioration of landscaping features, and in dry seasons, presents a fire hazard, and Whereas, this land is the property of the City of Los Angeles, and it is a relatively small narrow strip of land that is contiguous with, but outside the official surveyed boundary of the POLA, and whereas this has provided some rationalization that it is not the POLA's responsibility, despite the fact that landscaping features were installed on this property by the POLA at great expense.

Resolved, the Coastal San Pedro Neighborhood Council strongly urges that the City of Los Angeles transfer the ownership of this parcel of land between the current POLA surveyed boundary and Crescent Avenue from the Department of Public Works to the POLA (aka: the Los Angeles Harbor Department), and

Further resolved, the Coastal San Pedro Neighborhood Council strongly urges that the POLA commence frequent and regularly scheduled landscape maintenance, removal of invasive plants that were not part of the original landscape design, and trash cleanup of this area, by POLA Construction and Maintenance staff and gardeners.

Re: Vopak NOP/IS Dear Mr. Cannon,

Thank you for the opportunity to comment on the Vopak NOP/IS.

We have divided our comments into three parts. The first section concerns the lack of alternatives, a CEQA requirement. The second section concerns the liquid bulk operations. The third section addresses the dry bulk cement material operations.

Section One. The NOP/IS Does Not Include any Project Alternatives.

CEQA requires a discussion of reasonable alternatives to the proposed preferred project, including a "no project" alternative. There are none in the NOP/IS. CEQA also requires adoption of the least environmentally impactful alternative that meets the objectives of the project. As is discussed in the third section, a reasonable alternative exists that almost totally eliminates the impacts of 40,000 truck trips per year on local streets.

Section Two. Liquid Bulk Operations.

Baseline Year.

The NOP/IS suggests using 2021 as the baseline year. However, a better indicator of use might be a prepandemic year, such as 2018 (reference California Code of Regulations, 14 CCR § 15125, Environmental Setting). Please consider that consumption of the primary fuels which are the subject of the proposed Project was greatly diminished for the period of Covid slow-downs in the years 2020 and 2021.

Potential Soil Contamination and Cleanup.

The NOP includes "Utility and pipeline relocation and improvements at Berths 187–190" but does not include any information on soil contamination in the area of such work and does not address how such contamination will be removed or remediated. Two important principles are involved here. First, at the conclusion of a lease, the tenant has an obligation to restore the premises which means clean up the pollution they have caused. Second, when a long-term lease is contemplated as a renewal, that is a CEQA project requiring analysis and remediation before a new term permit is approved. In this case, the analysis should include the triangle park area across from the Banning Community Center where Vopak's manifold is located. It is known to be highly contaminated and needs to be remediated. It is directly east of the area now being prepared as a park for the Wilmington community.

Whereas, the proposed changes to the municipal lobbying ordinance (Council File 22-0560) would benefit Neighborhood Councils and stakeholders by increasing transparency, and Whereas, the proposed non-profit exemption of \$2,000,000 in gross receipts is excessive, inconsistent with IRS requirements, and would allow the vast majority of nonprofit corporations to gain exemption, thereby damaging transparency;

Therefore resolved, the Coastal San Pedro Neighborhood Council supports the proposed changes to the municipal lobbying ordinance (Council File 22-0560), particularly SEC. 48.11, which requires verbal disclosure of lobbyist status in verbal communications with Neighborhood Councils and Neighborhood Council members; and

Further resolved, the Coastal San Pedro Neighborhood Council recommends that the proposed nonprofit exemption be changed to \$200,000 in gross receipts or \$500,000 in assets. Council File 22-0560
