PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS — The public is requested to dial *9, when prompted by the presiding officer, to address the assembly on any agenda item before action is take on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the assembly's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the assembly is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Public comment may be limited to a fixed time per speaker by the presiding officer of the assembly. Those wishing to make comment, but not wanting to speak publicly, may submit written communications to the Board.

This meeting is advisory in nature to the Coastal San Pedro Neighborhood Council Governing Board. Any decisions made at this meeting are not considered to be Governing Board actions, unless it is given the power to act on an item, and shall go forward as recommendations to the Governing Board for a final vote at a regular or special Governing Board meeting. A quorum of the Governing Board members may be present. Stakeholders and Governing Board members present at the meeting may suggest items for the Governing Board agenda. All Governing Board members and committee chairs (or vice-chairs in the chair's absence) present at the meeting may vote on placing items on the agenda.
