Resolved, the Coastal San Pedro Neighborhood Council requests that with respect to the POLB Pier Wind Terminal Development Project the following issues are investigated:

Field Code Changed

- \* Is any public land being ceded to private interests who owns/operates the project
- \* Use of or effects on tidelands or navigable waters for private use
- \* Environmental impacts on land, water, flora and fauna
- \* Design being proposed that would result in the least amount of environemental damage
- \* Displacement of people, if any
- \* Project alternatives that do not require constructing new land in the ocean, including consideration of repurposing of existing underutilized manufacturing facilities on existing land or use of other existing underutilized government property
- \* Project alternatives including a smaller amount of land—is 400 acres a reasonable amount of land—need comparative information from other similar projects/sites
- \* No project whether project would be better done in other ports, including POLA
- \* Remediation of DDT and munitions on the ocean floor when obtaining fill for the new land or dumping of the material into ocean waters
- \* Materials that will be used and disposition of any by-products
- \* Whether proper/adequate notice was given to San Pedro residents
